
- St. John's, St. Mary's, St. Peter's, and Wright Settlement Cemeteries in Rome

#### **ADVOCACY IN ACTION – TAKE ACTION NOW**

In May the Chapter participated in MOAA's Advocacy in Action Campaign. Our team met virtually with Representatives Tenney (R-22), Delgado (D-19) and Malliotakis (R-11) and presented information on three pending legislative issues (Comprehensive Toxic Exposure Reform, Tricare Young Adult Parity and Basic Needs Allowance) of importance to veterans. The results of our efforts, to date are as follows: Rep Tenney signed on as cosponsor of all five bills pertaining to the issues within 10 days of our meeting;

whereas Reps Delgado and Malliotakis have yet to give formal support to any of the measures. However, according to our State Council, the appeal for support to members of the NY Congressional delegation was very positive and well worth the effort.

As a Chapter we will participate in AiA next year because nonpartisan legislative advocacy is a big part of our mission. Also, through our service, each one of us is highly qualified to be advocates and you don't have to wait until next Spring. You can make a difference today by sending an online thank you to Rep Tenney for her support. # **HEALTH CARE**

#### VA ROME COMMUNITY-BASED OUTPATIENT CLINIC

#### **DIRECTOR BILL HAMELIN**

Due to the virus pandemic, volunteers were not permitted to operate within the VA from 16 March 2020 through 01 September 2020. However, from 01 January 2021 through 13 September 2021, our volunteers assisted 1,316 veterans and provided 747 volunteer hours at the Rome Donald J. Mitchel VA clinic. These volunteer efforts have

saved the VA \$21,857.11 in costs thus far in 2021. Our volunteers provide the required in-person authentications and can now use VA Video Connect services and telephone services to authenticate veterans remotely. We now contact veterans through email and telephone with information regarding registering for a "Myhealthevet" account. So far over 700 contact emails have been sent to veterans.

Effective 30 September, all veterans who have an Advanced Myhealthevet account (MHV) will have to upgrade to a Premium account. All Advanced accounts will be eliminated by the VA. If you have an Advanced account and desire to upgrade, please give Bill, Steve, or Joe a call at 315-334-7118 for assistance on how to best accomplish this.

Many medical appointments are being done "virtually" and are well received by most veterans.

Due to the clinic operating on a "limited" access methodology to prevent overcrowding; entry into the clinic has been modified as follows:

- When a veteran has an appointment, they are not allowed to enter the facility until 15 mins. prior to that appointment.
- Masks must be worn at all times, and temperatures are taken upon entry.
- Cloth masks are not acceptable. Masks are available when you enter if you do not have one.
- There are a few quick screening questions that are asked to complete the process.
- No one is allowed to accompany a veteran to their appointment unless it is medically required to provide assistance to that veteran during their visit.

<u>Flu shots will begin on 16 October 2021</u>. We are planning to start drive up FLU clinics on October 16th. You may also share the following information which will also be on the postcard the Veterans receive about the FLU shot clinic.

or by calling 1-877-881-7618. Included are most CVS, Walmart, Costco, Wegmans, Safeway and Kroger pharmacies. Present your government issued ID care (driver's license or VA ID card) and request that your vaccination documentation be forwarded to your VA provider.

<u>Audiology and Podiatry support is now available</u> at the clinic twice a week, an appointment is required. In the future Cardiology, ENT, ECHO, GYN, and perhaps some limited general surgery will be available. In addition, a CATSCAN machine will be installed. All these efforts and improvements are being made to enhance veteran care and reduce travel.

<u>Women's Veteran Health Clinic</u>: The Rome VA clinic has established a robust and excellent woman veteran clinic that is now in full operation. It is conducted by PA Debora Cardinal. Female veterans can request assignment for treatment through this clinic or they can remain with their current primary care provider. Any questions regarding the clinic or registering to utilize it can be made at 315-334-7100 extn: 57318.

#### **VA RED COAT AMBASSADOR PROGRAM**

The VA Red Coat Ambassador program is a special volunteer program instituted at the Syracuse VA Medical Center and its associated Primary Care clinics. This program allows volunteers to assist veterans with specialized computer programs, such as Myhealthevet and Ebenefits and act as an informal ombudsman, assisting veterans by providing answers to a myriad of questions and ensuring the veteran contacts the proper resource for any assistance they might need. Any issues faced by the veteran that cannot be resolved by the Red Coat Ambassador, can then be escalated to the immediate attention of the Clinic Nurse Manager for resolution. This methodology has greatly reduced the frustration and delay sometimes encountered by veterans navigating through the VA.

Myhealthevet allows veterans the ability to access, interact, view, or even save, their medical information, which includes lab test results, prescription ordering and tracking, medical imaging, communicating with their primary care team (and other clinics) and making in-person and video connect appointments. It also accepts veteran input on a variety of health-related items like weight, blood pressure, medical treatment from outside the VA and OTC medications.

Ebenefits is a program that is undergoing a phase out/transition. Currently it allows veterans to access their disability information, make an application for benefits, track compensation exam results, apply for VA loan certificate, track compensation payments, appeals, and many others. VA is trying to simplify access for veterans to various veterans' information and Ebenefits and is transitioning over to VA.GOV.

GRUC-MOAA volunteers receive specialized training with these programs to assist veterans with enrollment and usage of these programs. Each year they must complete the Health Insurance Portability and Accountability Act of 1996 (HIPPA), Information Security, and Myhealthevet training through the VA Talent Management System (TMS). In addition, our volunteers have provided in-depth training classes to the Rome VA clinic staff on Myhealthevet and Ebenefits so they can fully understand what these programs can provide for the veterans but also how the staff/providers can use this system to be more effective and efficient.

Chapter members who perform this mission five days a week are: CMDR Stephen Mercurio, USN (RET), CW4 William J. Hamelin Jr, USA, (RET), and LTCOL Joseph Maurer, USA, (RET).

#### **VETERAN USE OF URGENT CARE FACILITIES APPROVED**

As part of the VA MISSION ACT of 2018, Veterans who have received medical care from the VA, or VA sponsored community providers, anytime during the last 24 months are now eligible to utilize URGENT CARE. If you are in Priority Group 1~5, the first 3 visits in a year are free, and after that there is a \$30 co-pay for each visit. Priority Groups 6~8 will incur co-payments of \$30 for each visit. WELL NOW Locations are available throughout NY state (and US). If the veteran encounters problems, call 866-620-2071 for assistance.

#### **OPTICAL SERVICES THROUGH THE VA**

Do You Wear Glasses? Need a new set of frames & lenses....do you get your glasses from the VA? They provide them for you at (normally) no cost. There is an extra charge for tinted glasses. If you are enrolled in the VA you are eligible through the VA. Fort Drum Optometry Clinic will also provide one free pair of glasses each year. You can walk

into the clinic and present your eyeglass prescription (must be within the last year). The Optometry Clinic is located at 10501 Euphrates River Valley Rd., Fort Drum, NY. You will have to pick them up at Ft. Drum, no delivery.

The Navy also has a program where they will provide you with one free pair of glasses each year. It does not matter what Military Service a person served in either. Here's the site for that process below:








#### FT. DRUM RETIREE DAY

#### **DOD TRAVEL INFORMATION**

The Department of Defense has established an official DOD sponsored/sanctioned web page that retirees can access for reduced prices with air flights, hotels, etc. The American Forces Travel page is located at this address:

After you select your hotel, flight, etc., and before it lets you proceed further, it will ask for some information to verify your eligibility (through ID.ME). Once your eligibility has been approved it will allow you to proceed. DOD has a contract through Priceline to provide discounts for military personnel and retirees.

#### **ONEIDA COUNTY VETERANS REPRESENTATIVES**

If you need to file a VA compensation claim, and live in Oneida County, please contact the Oneida County Veterans Service Office located within the Rome VA clinic. Representatives Joseph Perrone, and Dan Gowey are available to assist veterans through this complex process. If you have any questions regarding a medical condition that was incurred through military service, primary or secondary injuries, and wondering if filing a claim would be proper, please call or stop by their office and they will be happy to assist. Please inform your spouses, that if you, as the veteran, die from a service-connected injury, they may be entitled to Dependent Indemnity Compensation (DIC) payments. They can also call or stop by for a quick determination if they qualify for these monthly payments.

#### **NEW YORK STATE LEGISLATIVE LINES BEING RE-DRAWN**

Subsequent to the 2020 Census results, the New York State Independent Redistricting Commission (IRC) began its work to redesign legislative district boundaries that will affect State and Federal legislative boundaries for the next 10 years. The IRC is a 10-member body created by New York voters comprised of the following members:

IRC Members are selected based on these rules: Two are appointed by the New York State Senate Majority Leader and Temporary President, two are appointed by the New York State Senate Minority Leader, two are appointed by the Speaker of the New York State Assembly, and two are appointed by the New York State Assembly Minority Leader. The final two members are then selected by these eight appointees. Neither can be enrolled as a Democrat or Republican in the past five years. Additionally, appointing authorities have consulted with organizations devoted to protecting the voting rights of minority and other voters concerning their appointments. The Commission members must be registered voters in New York State.

Pursuant to Article III, Section 4(c) of the New York State Constitution, the New York State Independent Redistricting Commission (the "Commission") will hold a series of fourteen public hearings across the state to receive feedback on its draft redistricting plan for state legislative and congressional election districts.

The first meetings of the IRC were held virtually on August 15<sup>th</sup>. The resulting 'maps' were released on September 15<sup>th</sup>. The IRC will now begin review / comment sessions throughout the state where residents can testify relating to the proposed legislative maps. The schedule of IRC Public Hearings in our area follows below. At completion of the public hearings the IRC with vote on and certify the new district maps prior to their presentation to the NYS Legislature for review and approval.
