



Rome VA Clinic UPDATES

Flu Shots:

Rome:

 Oct 15, 22 & Nov 5 8:00 AM - Noon. No appointment needed, however, the clinic only serves vets using Rome CBOC as their primary care.

Syracuse:

• Sep 27, 28, 29 & Oct 4, 5, 6, 11, 12, 13, 18, 19, 20, 25, 26, 27 9:00 AM - 2:00 PM No appointment needed.

Visit Procedures:

The Rome VA clinic is still operating on a "limited" access methodology to prevent overcrowding; entry into the clinic continues to be modified as follows:

- When a veteran has an appointment, they are not allowed to enter the facility until 15 minutes prior to that appointment.
- Masks must be worn at all times.
 - Cloth masks are not acceptable. Masks are available when you enter if you do not have one.
- There may be a few quick screening questions that are asked to complete the process.
- No one is allowed to accompany a veteran to their appointment unless it is medically required to provide assistance to that veteran during their visit.

Some medical appointments are still being done "virtually" and are well received by most veterans. "In person" appointments with your primary care team are increasing and heading back into the normal range.

Renovations coming: Major renovations and improvements to the VA clinic are taking place. Completion is scheduled for some time in 2023.

- An elevator shortcut corridor is coming
- The 2nd floor area is undergoing major renovations so additional space can be utilized to increase care for veterans
- New heating, ventilation, and air conditioning units will be installed
- The Myhealthevet office has been temporarily moved to room 1232 (office just to the right side of our office 1233)

ROME HIGHWAY DEDICATED to Korean War Veterans

Part of Route 365 in Rome has been named the Oneida County Korean War Veterans Memorial Highway to honor those who fought in the 1950-53 conflict.

New York State Senator Joseph Griffo, R-Rome, and Assemblywoman Marianne Buttenschon, D-Marcy, sponsored the legislation that led to the dedication. Governor Kathy Hochul recently signed the legislation into law.



NEW ID CARDS – first change in 30 years

DoD plans to phase out and cancel the existing ID cards in 2026.







<u>The Next Generation Uniformed Services ID (Nex Gen USID) card</u> is a replacement for the previous version of United States military IDs for retired servicemembers, dependents, spouses, and others who need an official ID to access installations, services, and vehicles controlled by the Department of Defense.

The Next Generation USID card will incorporate an updated design and security features to deter counterfeiting and fraud, and will be printed on a plastic cardstock.

GRUC Bill Hamelin says "If you currently have a Military Retiree/Dependent ID card that "DOES NOT EXPIRE" and states "INDEFINITE", you will still need to apply for a new ID card replacement within 4 years (the end of 2026). The new card type will be replacing the current cards we now have. They will be similar to the current active-duty CAC cards. These cards will still be INDEFINITE but have better security. No hurry, we have 4 years, but if not done by then, the old cards will not be accepted."

Nearly 14,000 Pharmacies leaving TRICARE - October 24th

Impacted beneficiaries will receive a letter from Express Scripts with a list of alternative innetwork pharmacies. Walgreens and CVS remain in-network, as do many grocery store pharmacies and smaller chains.

After October 24, 2022, beneficiaries who continue to fill prescriptions at departing community pharmacies will pay the full retail price for the medication.

To transfer a prescription, beneficiaries can:

- Take their prescription bottles to another participating pharmacy in the network. The pharmacist there will contact the previous pharmacy and transfer the prescription.
- Call the new pharmacy and ask the pharmacist to obtain the prescription information from the old pharmacy.
- Ask their doctor to send the prescription information to the new pharmacy.
- Visit the Express Scripts website to switch eligible medications to home delivery.

SBP-DIC Offset Gone!

Congress made changes to the Survivor Benefit Plan (SBP) to phase out the offset for surviving spouses who are also receiving Dependency and Indemnity Compensation (DIC) from the Department of Veteran Affairs (VA).

Jan 1, 2023 – SBP-DIC offset will be fully eliminated. SBP payments will no longer be offset (reduced) by DIC. Spouses will receive full SBP (issued by DFAS) and full DIC (from the VA).

There is no action you need to take as a retiree for the changes to apply to your surviving spouse. However, check your RAS to ensure your SBP beneficiary is up to date (especially important if you have a former spouse).

HEALTH CARE INFORMATION – BILL HAMELIN

GRUC volunteers work in a daily capacity at the Rome, NY, Donald J. Mitchell, VA clinic. Chapter members who perform this mission five days a week are: CDR Stephen Mercurio, USN (RET), CW4 William J. Hamelin Jr, USA, (RET), and LTC Joseph Maurer, USA, (RET). GRUC volunteers receive specialized training with these programs to assist veterans with enrollment and usage of these programs. Each year they must complete the Health Insurance Portability and Accountability Act of 1996 (HIPPA), Information Security, and Myhealthevet training through the VA Talent Management System (TMS). In addition, our volunteers have provided in-depth training classes to the Rome VA clinic staff on Myhealthevet and Ebenefits so they can fully understand what these programs can provide for the veterans but also how the staff/providers can use this system to be more effective and efficient.

Audiology and Podiatry support is now available at the clinic twice a week, an appointment is required. Please call 315-425-2437 (Audiology) to set up an appointment. To order additional batteries and other accessories, please call 1-303-273-6200 and select option 2.

Women's Veteran Health Clinic: The Rome VA clinic has established a robust and excellent woman veteran clinic that is now in full operation. It is conducted by PA Debora Cardinal. Female veterans can request assignment for treatment through this clinic or they can remain with their current primary care provider. Any questions regarding the clinic or registering to utilize it can be made at 315-334-7100 extn: 57318.

VA Red Coat Ambassador program: The VA Red Coat Ambassador program is a special volunteer program instituted at the Syracuse VA Medical Center and its associated Primary Care clinics. This program allows volunteers to assist veterans with specialized computer programs, such as Myhealthevet and Ebenefits and act as an informal ombudsman, assisting veterans by providing answers to a myriad of questions and ensuring the veteran contacts the proper resource for any assistance they might need. Any issues faced by the veteran that cannot be resolved by the Red Coat Ambassador, can then be escalated to the immediate attention of the Clinic Nurse Manager for resolution. This methodology has greatly reduced the frustration and delay sometimes encountered by veterans navigating through the VA.

MyHealthyVet: Myhealthevet allows veterans the ability to access, interact, view, or even save, their medical information, which includes lab test results, prescription ordering and tracking, medical imaging, communicating with their primary care team (and other clinics) and making in-person and video connect appointments. It also accepts veteran input on a variety of health-related items like weight, blood pressure, medical treatment from outside the VA

and OTC medications. **NOTE:** Myhealthevet is now requiring a 2nd level authentication process to access your Myhealthevet (MHV) account. This will be done through an email or text verification. Access your MHV account to set this process in motion.

Effective September 30, 2021, all veterans who had an Advanced Myhealthevet (now known as Basic/Matched) account (MHV) will have to upgrade to a Premium account. All Advanced accounts have been eliminated by the VA. If you had an Advanced account and desire to upgrade, please give Bill, Steve, or Joe a call at 315-334-7118 for assistance on how to best accomplish this.

Ebenefits: Ebenefits is a program that is undergoing a phase out/transition. Currently it allows veterans to access their disability information, make an application for benefits, track compensation exam results, apply for VA loan certificate, track compensation payments, appeals, and many others. VA is trying to simplify access for veterans to various veterans' information and Ebenefits and is transitioning over to: **VA.GOV**

Optical services through the VA: Do You Wear Glasses? Need a new set of frames & lenses....do you get your glasses from the VA? They provide them for you at (normally) no cost. There is an extra charge for tinted glasses. If you are enrolled in the VA you are eligible through the VA.

- Fort Drum Optometry Clinic will also provide one free pair of glasses each year. You can walk into the clinic and present your eyeglass prescription (must be within the last year). The Optometry Clinic is located at 10501 Euphrates River Valley Rd., Fort Drum, NY. You will have to pick them up at Ft. Drum, no delivery.
- The Navy also has a program where they will provide you with one free pair of glasses each year. It does not matter what Military Service a person served in either. The Customer Service Line is available: 757-887-7600, option 1. Here's the link to the Navy Optical site for that process:

Veteran use of urgent care facilities approved: As part of the VA MISSION ACT of 2018, Veterans who have received medical care from the VA, or VA sponsored community providers, anytime during the last 24 months are now eligible to utilize URGENT CARE. If you are in Priority Group 1~5, the first 3 visits in a year are free, and after that there is a \$30 copay for each visit. Priority Groups 6~8 will incur co-payments of \$30 for each visit. WELL NOW

Locations are available throughout NY state (and US). If the veteran encounters problems, call 866-620-2071 for assistance.

VETERANS INFORMATION

FILE a VA Claim: If you need to file a VA compensation claim, and live in Oneida County, please contact the Oneida County Veterans Service Office located within the Rome VA clinic. Representatives Joseph Perrone, and Dan Gowey are available to assist veterans through this complex process. If you have any questions regarding a medical condition that was incurred through military service, primary or secondary injuries, and wondering if filing a claim would be proper, please call or stop by their office and they will be happy to assist. Please inform your spouses, that if you, as the veteran, die from a service-connected injury, they may be entitled to Dependent Indemnity Compensation (DIC) payments. They can also call or stop by for a quick determination if they qualify for these monthly payments.

LEGAL ASSISTANCE: Military retirees, don't forget you can obtain, at no cost to you, wills, healthcare proxy/living wills, and Power of Attorneys from the Ft. Drum Legal office, located at Clark Hall, 10720 Mt. Belvedere Blvd., Ft. Drum, NY 13602. The number to make an appointment is: 315-772-5261.

DOD TRAVEL INFORMATION: Space A travel is back to pre-pandemic levels effective 4/26/22, although some COVID restrictions may still apply.

The Department of Defense has established an official DOD sponsored/sanctioned web page that retirees can access for reduced prices with air flights, hotels, etc. The American Forces Travel page is located at this address:

After you select your hotel, flight, etc., and before it lets you proceed further, it will ask for some information to verify your eligibility (through ID.ME). Once your eligibility has been approved it will allow you to proceed. DOD has a contract through Priceline to provide discounts for military personnel and retirees.
